FNMA 2025-RPL2 Pool Characteristics

- Approximately 3,058 reperforming loans.
- Approximately \$560.5 million in unpaid principal balance (UPB), offered in one pool.
- Loans are subserviced by NewRez LLC, d/b/a Shellpoint Mortgage Servicing ("NewRez LLC") for Fannie Mae.
- Marketed with Citigroup Global Markets, Inc. as advisor.

FNMA 2025-RPL2 Timeline

- August 12, 2025: Marketing begins
- August 14, 2025: Data room open for bidders
- September 4, 2025: Bids due
- September 5, 2025: Bid awarded
- Late-October 2025: Due diligence ends
- Late-October 2025: Sale closes
